<u>Kleenheat "WIN the ultimate foodie appliance and entertainers pack" – Perth 2018 Good Food and Wine Show" Terms and Conditions</u>

Participation

- 1. The promoter is Wesfarmers Kleenheat Gas Pty Ltd ABN 40 008 679 543 of Building 161, Car Park 12, Murdoch University, Murdoch WA 6150 ("Kleenheat" or "we").
- 2. Instructions on how to enter and other details contained within promotional, electronic and print materials form part of the terms and conditions. By participating in this competition entrants shall be deemed to agree to abide by these terms and conditions.
